TERMS

Companion Camp will provide Pet Services that meet or exceed North Carolina Department of Agriculture's licensing requirements. Companion Camp will exercise all reasonable precautions against injury, escape, accidents, or death of the pet. The owner will hold Companion Camp, its employees, officers, agents, and assigns free of all responsibility and liability for illness, injury, or death of his/her pet, the owner, or any person brought onto the premises of Companion Camp by the owner in the absence of gross negligence. The owner further agrees to be solely responsible for any and all acts or misbehavior of his/her pet(s) while in the care of Companion Camp, including, but not limited to, payment of costs for injury to staff or other animals or damage to facilities caused by the pet. Pet owners agree to indemnify Companion Camp with respect to any acts caused by the pet, the owner, or persons brought onto the premises by owner with respect to injury, etc., of other pets, property, or persons. The owner agrees to abide by all of Companion Camp LLC's policies. The owner agrees to pay all costs and any charges for special services requested for the pet during the time the pet is in the care of Companion Camp. The owner further agrees that the pet shall not leave Companion Camp until all charges are paid. If a pet is left for ten days beyond the last day of the Contract Period without being picked up by its owner, Companion Camp may take the pet to an animal shelter and have no further responsibility to the pet or the owner. Any costs associated with such an action are the sole responsibility of the pet owner. Companion Camp will not release a pet to anyone, other than its owner, without specific instructions from the owner.

This contract shall be governed by the Laws of the State of North Carolina with venue for disputes in Chatham County. Furthermore, this is our complete agreement with no other agreements beyond what is included within this document.

POLICIES

Vaccinations

To safeguard the health and well-being of all our guests, all dog campers must have current rabies, DHLPP and bordetella vaccinations. All cat campers must have current

rabies and FVRCP vaccinations. Written proof of these vaccinations must be provided to Companion Camp before boarding. All campers must be free of fleas and ticks before visiting. Although Companion Camp maintains a sanitary facility, in a camp setting our campers do encounter nature's insects. Therefore, campers are required to be treated with a comprehensive insect repellent such as Frontline Plus or Advantix.

Check-in and Check-out

Check-ins and check-outs are available during Companion Camp's regular lobby hours.

Veterinarian Care

In an emergency or if your pet needs veterinary care, we will utilize the services of our on-call veterinary service, Tri-County Veterinary Services. Transportation fees similar to the pick up and delivery option will apply. In such cases, pet owners indemnify Companion Camp with respect to all pet medical care.

Pet Items

Your pet is welcome to bring a favorite blanket or toys from home. However, we cannot be responsible for these items.

Food and Medication

Companion Camp provides high quality pet food (currently Iams) for our campers. However, you are welcome to bring your own pet's food if you prefer. All owner food must be in clearly labeled, rigid air-tight food storage containers in amounts appropriate for your pet's stay. Companion Camp recognizes that some pets require medication. Our staff is experienced in administering nasal, oral, and injected medications. Owners must bring all medications in their original containers with full veterinary instructions.

Roommates

Dogs in the same family are welcome to room together. However if difficulties arise, we reserve the right to house them separately at the individual boarding rate.
